

MINNCOR Industries Warranties Casework and Cabinetry

RIGHTS AND WARRANTIES

MINNCOR Industries provides a five (5) year limited materials only warranty to the property owner for a period of five years from the original date of purchase. MINNCOR Industry warrants that all components will be free to defects in material and workmanship under normal use. This warranty is only applicable to products installed and used in typical North American residential applications. This warranty and all its claims are non-transferable.

Should defects in materials or workmanship be present during the applicable warranty period, MINNCOR Industries, at its sole discretion, will either repair or replace the defective cabinet or affected components. This warrant covers parts and materials manufactured and supplied by MINNCOR Industries. This warranty statement does NOT include counter tops, appliances, plumbing fixtures, or labor costs to remove and reinstall affected product. Product that is damaged during installation or while being held in non-MINNCOR storage prior to installation is also excluded from the 5 year limited warranty.

This warranty will be void if the ownership of the property changes. Cabinets that are damaged by misuse or abuse, acts outside of human control (i.e. Weather or other environmental conditions, flooding, fire), and exposure to extreme temperatures are also excluded from any warranty claims against MINNCOR Industries. Excluded from this warranty are the effects of normal wear and tear or exposure to moisture including, but not limited to leakage, improper drainage or faulty plumbing, or excessive exposure to water. This warranty will be null and void if it is determined that unapproved chemical products were used in conjunction with cabinet cleaning.

Wood products naturally vary in color, grain, or other innate characteristics and may show changes over time. These changes occur when exposed to: UV light, smoke, harsh chemical cleaners, vinegar or vinegar related products, citrus or citrus based cleaners and detergents. These changes are considered normal and typical to the cabinet making industry and are not warranty considerations. MINNCOR Industries provides clear and concise instructions for the [care and cleaning of your MINNCOR Industries cabinetry](#). Adherence to those instructions will contribute to extending the life of your MINNCOR cabinetry.

MINNCOR Industries reserves the right to, and may over time, make changes in design, construction, or finishing elements. Warranty claims deemed valid will be repaired or replaced in accordance with processes in place at the time of the warranty claim. MINNCOR Industries will make every effort to provide a product regarded as equal or greater to the original.
